

# Who does this Policy apply to?

The Native Title rights of Yawuru People is recognised, as is their right to access Gumaranganyjal.

This policy is intended to apply to all visitors to the Station. Different visitors may have different connection to, and purposes for, accessing Gumaranganyjal. Therefore, varying degrees of access will be applied based on the identified group an individual falls within.

These groups are;

**Yawuru People**, as the recognised Native Title holders of the area

**Non-Yawuru Aboriginal community members**, with historic connections to Gumaranganyjal and with permission from a Yawuru Person

**Other general visitors**, such as contractors, NBY employees or consultants

This brochure provides a broad guide only, and it is recommended that the Safe Access Policy be reviewed in full via the Yawuru website.

# Before accessing the Station...

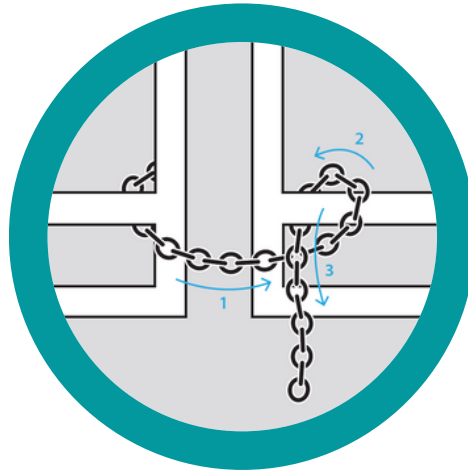
Yawuru People are requested to, and all other visitors **must**, contact the Station Manager at least 48 hours prior to entry to the Station.

The following information should be provided to the Station Manager:

- General purpose for going onto the Station.
- Area(s) of the Station to be visited.
- Number of people.
- Number and type of vehicles, including registration number.
- Any intention to bring a firearm onto the Station.



# Gates, grids and fences...



Gates, grids and fences are important Station infrastructure. All visitors accessing Gumaranganyjal must:

- Ensure all gates adjacent to Great Northern Highway and Broome Road remain closed at all times.
- Ensure any other gates are left as they are found, i.e. always close a 'closed gate' and always leave open an 'open gate'.
- Ensure no fences or gates are willfully damaged, cut or altered in any way.
- Advise the Station Manager or a Station employee, at the earliest opportunity, if any damage to a gate, fence or other item of infrastructure is caused or observed.
- If you observe any deceased or injured cattle or any other animal welfare concern, please contact the Station Manager as soon as possible.

# Hunting and use of firearms...

All visitors seeking to bring a firearm onto the Station **must**:

- Raise the request with the Station Manager during the initial phone contact.
- Identify the area(s) on the Station where the firearm is proposed to be used.
- Meet with the Station Manager in order to display a copy of their WA firearms licence.

Yawuru People and non-Yawuru Aboriginal community members (with permission from a Yawuru Person) may hunt or gather Australian native species for traditional or cultural purposes.
